THIS DEED WITNESSES as follows:

1. INTERPRETATION

Unless otherwise defined in this Deed or the context requires otherwise, words and expressions used in this Deed (including the recitals) have the meanings assigned to them in the Registration Deed of Representation.

2. ACCESSION

- 2.1 With effect from the date of this Deed, the Acceding Registration Representative shall, without any further action by a VCS Registry, any Registration Representative or any other party, be bound by the terms of the Registration Deed of Representation as if it were named in the Registration Deed of Representation.
- 2.2 For the avoidance of doubt, the Acceding Registration Representative hereby acknowledges that a VCS Registry shall hold this Deed for the benefit of Accountholders holding VCUs relating to the Project at any given time.

3. EXISTING REGISTRATION REPRESENTATIVES

Each of the Existing Registration Representatives hereby acknowledges and agrees with the accession of the Acceding Registration Representative to the Registration Deed of Representation in accordance with the terms of this Deed.

4. **GOVERNING LAW AND JURISDICTION**

This Deed and all non-contractual obligations arising out of or in connection with it are governed by English law, and the English courts shall have exclusive jurisdiction to settle any dispute arising from or connected with this Deed, including a dispute regarding the existence, validity or termination of this Deed or the consequences of its nullity.

5. **COUNTERPARTS**


This Deed may be executed in any number of counterparts, which when executed and delivered is an original and all of which together evidence the same deed.






