(a) summary of the recent activities, events and actions related to the Project:

The main purpose of this project activity is to generate clean form of electricity through renewable solar energy source for sale of electricity to the grid. Adani Green Energy (Tamilnadu) Limited (AGETL) is the promoter of the proposed project activity. The project activity involves installation of 216 MWAC (corresponding to 259.20 MWp) solar power project. The project is installed in the same project boundary at Village: Sangapadai & Pudukottai, Tehsil: Kamuthi, District: Ramanthpuram, State: Tamil Nadu. The electricity generated from project activity is sold under the Power Purchase Agreement (PPA), signed with

Tamil Nadu Generation and Distribution Corporation Limited (TANGEDCO) wholly owned by the Government of Tamil Nadu. The electricity generated from the project activity has been evacuated through 230 kV substation located at Kamuthi for consumption in the Indian Electricity Grid. The project has replaced anthropogenic emissions of greenhouse gases (GHG's) estimated to be approximately 330,952 tCO₂e per annum, thereon displacing average 351,366 MWh/year amount of electricity from the generation-mix of power plants connected to the Indian electricity grid, which is mainly dominated by thermal/fossil fuel-based power plant.
