2. ACCESSION

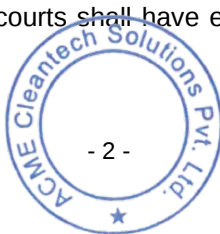

- 2.2 For the avoidance of doubt, the Acceding Registration Representor hereby acknowledges that Verra shall hold this Deed for the benefit of Accountholders holding VCU's relating to the Project at any given time.

3. EXISTING REGISTRATION REPRESENTOR

The Existing Registration Representor hereby acknowledges and agrees with the accession of the Acceding Registration Representor to the VCS Registration Deed of Representation in accordance with the terms of this Deed.

4. GOVERNING LAW AND JURISDICTION

This Deed and all non-contractual obligations arising out of or in connection with it are governed by English law, and the English courts shall have exclusive jurisdiction to settle any dispute



arising from or connected with this Deed, including a dispute regarding the existence, validity or termination of this Deed or the consequences of its nullity.

This Deed is delivered on the date written at the start of the Deed.

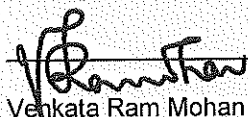


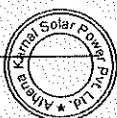
