

## 补充协议

### Supplementary agreement

本协议作为 2018 年 6 月 5 日和 2018 年 6 月 27 日甲乙双方签订的中节能张北绿脑包风电项目购买协议（下称“原协议”）和中节能甘肃昌马项目购买协议的补充协议。

This agreement is a supplementary agreement to the purchase agreements signed by both parties on June 5, 2018 and June 27, 2018 for the project of CECIC HKE Zhangbei Lvnaobao Wind Power Project (VCS727, hereafter referred to as Original ERPA) and CECIC HKC Gansu Changma Wind Power project.

甲、乙两方同意把下面两个项目转移到乙方账户，当购买期结束后，如果甲方和乙方未签署新的购买协议。2021 年 7 月 1 日前，乙方负责联络 APX 将项目从乙方账户中转移至甲方账户。

Party A and Party B agree to transfer the project to Party B's APX account. If Party A and Party B do not sign a new purchase agreement after the end of the purchase period, Party B will contact APX to transfer the above items from Party B's to Party A's account before July 1, 2021. The item 2.4 stated in the Original ERPA will revised from “The buyer agree to issue the project credits at least twice, the last issuance could not be later than December 31, 2019.” to “Both Party A and Party B agree to issue the project at least twice, the first issuance could not be later than December 31, 2019, if not, then Party B should pay to Party A according to the normal amount of the project credits issued for one year.”
