#### EFFICIENT AND CLEAN COOKING FOR HOUSEHOLDS IN NIGERIA UNDER THE GOLD STANDARD PROGRAMME OF ACTIVITIES (POA) 'ECO\_A\_BURN MULTI-COUNTRY CLEAN COOKING PROGRAMME'

##### Introduction

In most of the countries on the African continent cooking is done on either 3-stone fires or very inefficient traditional cookstoves, consuming a lot of fuel, in particular non-renewable firewood, and charcoal<sup>1</sup>. The high biomass consumption has negative impacts on the environment leading to deforestation and land degradation, Greenhouse Gas Emissions (GHG) emissions, loss of soil fertility and soils reduced ability of water

retention. Further, indoor air pollution through health-damaging pollutants while combusting firewood and charcoal result in diseases like e.g. pneumonia, stroke, ischemic heart diseases, chronic obstructive pulmonary diseases and lung cancer.

### **Purpose and technology of the project activity (VPA)**

The purpose of this VPA included under the Gold Standard Programme of Activities (PoA), 'ECO\_A\_BURN multi-country Clean Cooking Programme' - (GS10789), is the dissemination of highly efficient improved cookstoves to urban, peri-urban and rural users (households, communities, institutions, or SMEs) in Nigeria.

Several greenhouse gases (GHG), including carbon dioxide, are produced because of the incomplete combustion of biomass as used in cookstoves. More GHG emissions result from the use of biomass which is non-renewable. ICS improve heat transfer efficiency as compared to the baseline traditional cookstoves, thereby reducing both the amount of woody biomass used by unit appliance implemented and the emission of GHGs.

By using the ICS, the consumers assign and transfer all rights on the carbon credits to BURN Manufacturing Co., the Coordinating and Managing Entity of the PoA and Voluntary Project Activity (VPA) implementer. ICS are distributed through direct sale/distribution and by a variety of retail outlets across the country to end-users.

### **Target Group and Location**

The target group of the VPA are urban and peri-urban households communities, institutions, or SMEs using non-renewable biomass with a conventional system with no improved combustion air supply or flue gas ventilation system, i.e. without a grate or a chimney, prior to receipt of an efficient cooking stove. The VPA may cover urban and peri-urban areas across all the Regions of Nigeria

Though the PoA does not cover the replacement of non-renewable by renewable biomass for the moment, this option may be included later. Hence, this Local Stakeholder Consultation shall be also valid for any cooking technologies replacing non-renewable by renewable biomass.

### **Technology**

A VPA may deploy different ICS models designed and developed by BURN. The ICS models are highly efficient, and the designs consider the local cooking culture in the

project area to ensure that improvements in technology and improved standards of living do not come at the expense of cultural traditions. A VPA may opt to distribute other stove models over time.



### **Implementation plan**

The project started on 19/08/21 with the distribution of the first improved cookstoves. It is estimated that a total of 344,522 stoves will be distributed by the end of the first crediting period.

### **Carbon credits**

Greenhouse gas (GHG) emission reductions achieved through saving of non-renewable biomass (or at a later stage possibly through replacement of non-renewable by renewable biomass) will result in carbon credits following certification rules and procedures.

The revenues from the sale of carbon credits help amongst others to:

- Distribute improved cookstoves to a subsidized price affordable for end-users.
- Scale up and expand the program, thus reaching a wider range of end-users and generating more jobs.
- Further invest in R&D, hence, to produce high quality stoves at lower cost.
- Provide a reliable after-sales service.
- Sensitize and raise awareness amongst end-users about the benefits and how to use the improved cookstoves.

### **Contribution to Sustainable Development**

Besides reducing GHG emission in line with the United Nations Sustainable Development Goal (SDG) number 13 (Climate Action), this project will also seek to increase other long-term sustainability benefits for the end-users as well as the local environment.

Project activities under the PoA are expected to contribute to different Sustainable Development Goals (SDGs) in the following way:

1. Reduction in end-user expenses related to the purchase of fuel for cooking (in line with SDG 1 'No Poverty').
2. Time savings both for fuel procurement and cooking, thus more time is available for other tasks, like income generating activities or for growing food (in line with SDGs 1 'No Poverty', and 5 'Gender Equality').
3. Less harmful carbon monoxide and particulate matter during combustion in households, communities, institutions, SMEs will reduce indoor air pollution and thereby decrease of respiratory diseases, headache and itchy eyes, particularly for women and children who spend lot of their time in cooking activities (in line with SDG 3 'Good health and well-being' and 5 'Gender Equality').
4. Improved cookstoves cook faster than traditional stoves and use less fuel, enabling children, particularly girls to dedicate more time for education/school instead of for cooking (in line with SDG 4 'Quality Education')
5. Increased penetration of clean and reliable cooking technologies (in line with SDG 7 'Affordable and Clean Energy') and raising awareness of the related safety, economic, and environmental benefits (in line with SDG 4 'Quality Education').
6. BURN produces its cookstoves in a manufacturing facility located in Kenya, thus generating hundreds of jobs on the African continent. Other jobs are created for sales, marketing, distribution and monitoring staff. Continuous training results in permanent knowledge transfer to local people. BURN may open in future additional factories or assembly lines across the continent depending on the demand (in line with SDGs 1 'No Poverty' and 8 'Decent Work and Economic Growth').
7. Reduced deforestation and forest degradation in the areas where non-renewable biomass is used as a source of fuel. This will contribute to the overall stability of forest ecosystems which support biodiversity, watersheds and soil conditions (in line with SDG 15 'Life on Land').



### B.1.1. Appropriateness of methods

>> The invitations were sent at least 30 days (1 month) before the meetings date in English and in Hausa and were targeting a wide range of stakeholders to ensure a broad representation and diversified stakeholders opinions. Reminder emails were shared to the stakeholders two weeks before the meetings. Invitation emails were sent on 30/06/2022, at least one month prior to the date of the first meeting (01/08/2022). Email reminders were sent to the stakeholders closer to the date of the LSC meeting.

In summary, the following methods were used to invite stakeholders:

- Stakeholders with access to email were emailed an invitation together with a non-technical summary of the project and meeting agenda.
- Advertisements were published in local newspaper.
- Participants were invited through word of mouth I.e., via invitation letter, phone calls and in person invitation
- To reach social media users, invitations were posted on BURN’s website. The advertisement included the invitation text and the non-technical summary.
- Radio Announcements were done in local language before the meetings.

### B.1.2. Gender Sensitivity

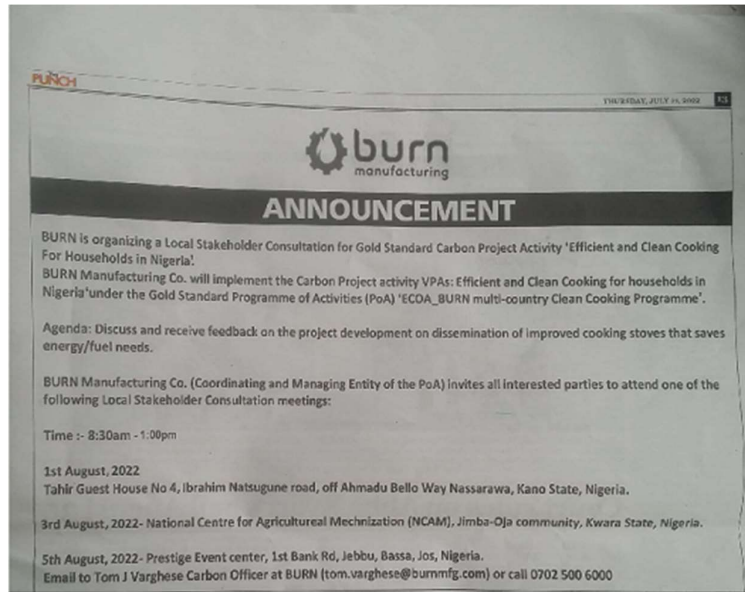

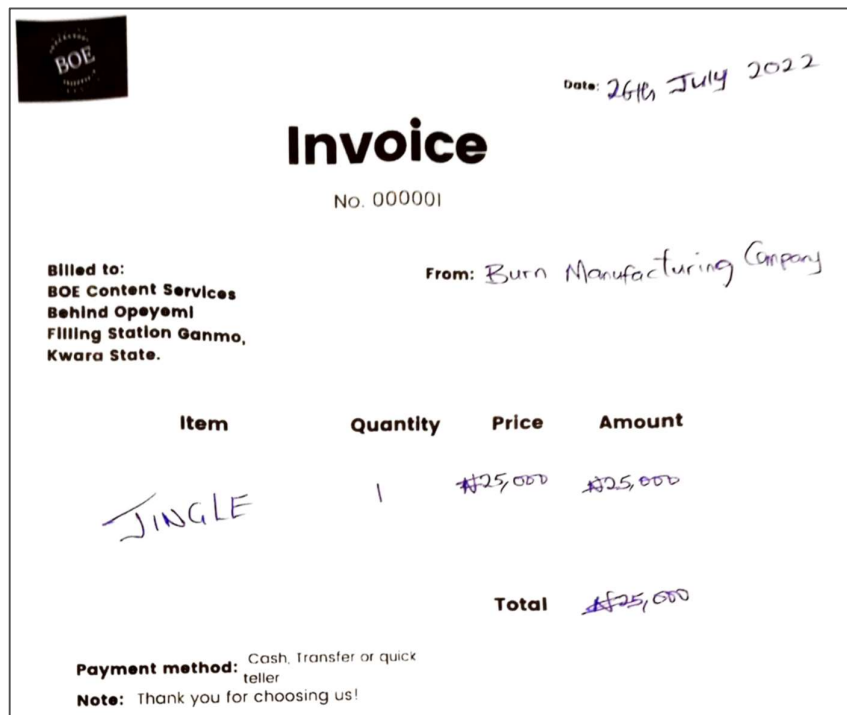

## **C.2. Minutes of physical meeting(s)**

>> The three meetings were carried out in the same order detailed in the minutes of the meetings below. Participants raised questions and concerns during the three meetings. Please refer to C.3 for a complete list of the questions raised during the meetings and the answers provided by BURN.

### **Minutes of the physical meetings in Kano, Kwara and Jos in Nigeria**

#### **Registration of participants:**

Participants who attended physically arrived and were asked to sign the attendance list. The online participants registered before joining the Online Meeting via Zoom Meetings platform.

#### **Welcome Remarks:**

Participants in person were welcomed by BURN's team leaders, for all the meetings. Introductions of the present participants were done for both the physical meetings and for the stakeholders participating online. The purpose of the meeting and the agenda were explained to the audience.

#### **Project Presentation:**

BURN's staff started the presentation by explaining the project in detail; they presented BURN Manufacturing, the main goals of the program and its benefits for the local communities, as well as the ICS technology involved in the project. They also took time to remind the stakeholders about climate change and its causes, and they briefly explained the theory of the carbon credits, carbon markets and the development of carbon projects. BURN team took some time to explain carefully to the stakeholders that the transfer of rights to the carbon credits generated using the stoves would be transferred to BURN as the Coordinating Management Entity of the entire project. The carbon waiver was demonstrated to be on the strap that wraps the stove box, and by the end user cutting this strap, they would be waiving their claims to any Verified Emission reductions generated using that stove. The purpose for this and the way in which BURN would use the revenues from the sale of the carbon credits was explained clearly in the presentation during the LSC meeting

#### **Questions and answers session:**

Stakeholders raised many questions about the price of the ICS and its quality, as well as the expected timeline for the project and the distribution plans. They expressed a lot of interest in the involvement of the communities and more particularly the involvement of women. Stakeholders also highlighted the importance of working with other Collaborators in both the Private and Public Sectors to ensure the Information reaches as many people as possible. All these questions and comments were fully and satisfactorily answered by the project proponents.

**Presentation of the Safeguarding Principles and Sustainability assessment of the project:**

BURN's staff briefly explained the project's Safeguarding Principles and their assessment. The stakeholders were continuously consulted for feedback and comments, as an open discussion. The meeting continued with a presentation of the SDGs, and on the positive impacts of the project on a few specific SDGs. Participants agreed with the assessment and didn't have further comments.

**Closure of the meeting:**

BURN's staff presented the grievance mechanism which was discussed and agreed by all stakeholders. Also, the next steps regarding project implementation and contact details were shared with participants. The evaluation forms were then distributed to the participants. The team expressed its appreciation to all participants who attended the meeting and who offered many constructive suggestions. Participants were then invited for the demonstration of the project stoves. The meeting closed with the distribution of Lunch.
