- (A) On **21 August 2021**, the Existing Registration Representatives made certain representations and warranties and undertook certain obligations under a registration deed of representation ("**VCS Registration Deed of Representation**").
 - (B) The Acceding Registration Representative hereby wishes to accede to and be bound by the terms of the VCS Registration Deed of Representation relating to project **Installation of high efficiency wood burning cookstoves in Malawi – Project 2, VCS 2372** (the "Project") as a Registration Representative with effect from the date hereof.
 - (C) The Existing Registration Representatives hereby wish to acknowledge the accession of the Acceding Registration Representative.

THIS DEED WITNESSES as follows:

1. INTERPRETATION

Unless otherwise defined in this Deed or the context requires otherwise, words and expressions used in this Deed (including the recitals) have the meanings assigned to them in the VCS Registration Deed of Representation.

2. ACCESSION

- 2.1 With effect from the date of this Deed, the Acceding Registration Representative shall, without any further action by Verra, any Registration Representative, or any other party, be bound by the terms of the VCS Registration Deed of Representation as if it were named in the VCS Registration Deed of Representation.
- 2.2 For the avoidance of doubt, the Acceding Registration Representative hereby acknowledges that Verra shall hold this Deed for the benefit of Accountholders holding VCU's relating to the Project at any given time.

3. EXISTING REGISTRATION REPRESENTORS

The Existing Registration Representatives hereby acknowledge and agree with the accession of the Acceding Registration Representative to the VCS Registration Deed of Representation in accordance with the terms of this Deed.

4. GOVERNING LAW AND JURISDICTION

This Deed and all non-contractual obligations arising out of or in connection with it are governed by English law, and the English courts shall have exclusive jurisdiction to settle any dispute arising from or connected with this Deed, including a dispute regarding the existence, validity or termination of this Deed or the consequences of its nullity.

5. COUNTERPARTS

This Deed may be executed in any number of counterparts, which when executed and delivered is an original and all of which together evidence the same deed.

6. DELIVERY

This Deed is delivered on the date written at the start of the Deed.


