2. Sichuan Furong Coal Mine Methane Utilization Project complies with the permission requirements provided for in the Measures for Operation and Management of Clean Development Mechanism Project in China, and assists China in achieving sustainable development.
3. Sichuan Furong Group's Limited Industrial Company is hereby authorized as China's participant to voluntarily participate in and carry out the project activity.
4. Sichuan Furong Group's Limited Industrial Company is permitted to transfer to Marubeni Corporation which is authorized by the Government of Japan no more than 1,130,000 tCO₂e in total Certified Emission Reductions (CERs).
