1 SUMMARY OF SUSTAINABLE DEVELOPMENT CONTRIBUTIONS

The main purpose of this project activity is to generate clean form of electricity through renewable solar energy source. The project is a bundled project activity which involves installation of 372 MW solar project in different states of India through SPVs.

Over the 10 years of first crediting period, the project will replace anthropogenic emissions of greenhouse gases (GHG's) estimated to be approximately 638,520 tCO_{2e} per year, thereon displacing 681,607 MWh/year amount of electricity from the generation-mix of power plants connected to the Indian grid, which is mainly dominated by thermal/fossil fuel based power plant.
