1 PROJECT DETAILS

1.1 Summary Description of the Implementation Status of the Project

CLP Wind Farms (India) Private Limited (CLPWF) has developed a green-field wind based electricity generation project at Andhra Lake, Pune District, in the State of Maharashtra. The project activity involves installation of 70 number of Wind World (India) Limited (formerly known as Enercon (India) Limited (EIL)) make E-53 Wind Turbine Generators (WTGs) to generate electrical power for export to the distribution licensee. Wind World (India) Limited (WWIL) is the equipment supplier and the operations and maintenance contractor for the Project. The Project is owned by CLP Wind Farms (India) Private Limited and WWIL is responsible for operation and maintenance of the wind farm.

Total capacity of the project is 56 MW. In the baseline scenario, the similar quantum of electricity would have been generated by the operation of grid- connected power plants and by the addition of new generation sources that would have led to emission of Green House Gases (GHGs).

The first WEG under this project has started commissioning since 19-Aug-2011 and has been under operation since then except for regular shutdowns considering O&M requirements. A comprehensive list of WEGs commissioning dates are provided under section 1.7. The expected operational lifetime of the project is for 20 years.

During this monitoring period the project activity has exported 114,770.64 MWh of net energy to the NEWNE Grid of India. The total emission reductions achieved during the monitoring period from 01-Jan-19 to 31-Jan-2020 (both days inclusive) is 108,882 tCO₂.

Project has begun generating GHG emission reductions from 19-Aug-2011. Hence, crediting period for VCS begins on 19-Aug-2011 and ends on 18-Aug-2021 i.e. 10 years crediting period which can be renewed for maximum 2 times.

1.8 Title and Reference of Methodology

The methodology applied for the project is ACM0002 of version 12.3.0 titled “Consolidated Baseline Methodology for grid connected electricity generation from renewable sources”. It has been referred from the list of approved methodologies for CDM project activities on the UNFCCC CDM website (<http://cdm.unfccc.int/methodologies/PAmethodologies/approved.html>).

ACM0002 draws upon the following tools which have been used in the VCS PD:

- Version 06.0.0 (EB 65, Annex 21, 25th November 2011) of the “Tool for the demonstration and assessment of additionality”;
- Version 02.2.1 (EB 63, Annex 19, 29th September 2011) of the “Tool to calculate the emission factor for an electricity system” and
- Guidance on assessment of investment analysis (Annex 05, EB 62)

1.9 Participation under other GHG Programs

The project has participated as CDM projects titled “Wind power project in Maharashtra, India – Andhra Lake Phase - I” and UNFCCC No: 6882. The project link is: <https://cdm.unfccc.int/Projects/DB/LRQA%20Ltd1343392693.61/view>. However, CLPWFPL has not claimed any CERs from the CDM project activity from project registration to till date. CLPWFPL has claimed the carbon credits from only one GHG programme during a monitoring period which would ensure that there will be no double counting of emission reductions

1.10 Other Forms of Credit

- Emission Trading Programs and Other Binding Limits: The project has not participated in any Emissions Trading Programs. The emission reductions generated for this duration of periodic verification would not be claimed under any other GHG programs
- Other Forms of Environmental Credit: The project proponent hereby confirms that the project has not sought or received any other GHG related environmental credit except CDM and submitted a declaration to DoE that CLPWFIPPL wouldn't claim any form of environmental credit except VCU for the said duration

1.11 Sustainable Development

The National CDM Authority (NCDNA) which is the Designated National Authority (DNA) for the Government of India (GoI) in the Ministry of Environment and Forests (MoEF) has stipulated four indicators for sustainable development in the interim approval guidelines for Clean Development Mechanism (CDM) projects from India¹. The contribution of this project activity towards in terms of these four indicators is provided below:

1. Social Well Being:

- The project activity has led to the development of supporting infrastructure such as road network etc., in the wind park location, which also provides access to the local population.
- The project activity leads to alleviation of poverty by establishing direct and indirect benefits through employment generation and improved economic activities by strengthening of local grid of the state electricity utility.
- Use of a renewable source of energy reduces the dependence on imported fossil fuels and associated price variation thereby leading increased energy security.

2. Environmental Well Being:

- The project activity involves use of renewable energy source for electricity generation instead of fossil fuel based electricity generation which would have emitted gaseous, liquid and/or solid effluents/wastes.
- Being a renewable resource, using wind energy to generate electricity contributes to resource conservation. Thus, the project causes no negative impact on the surrounding environment contributing to environmental well-being.

3. Economic Well Being:

- The project activity requires temporary and permanent, skilled and semi-skilled manpower at the wind park; thus, project activity has created additional employment opportunities.
- The generated electricity is being fed into the Western regional grid through local grid, thereby improving the grid frequency and availability of electricity to the local

consumers (villagers & sub-urban habitants) which has provided new opportunities for industries and economic activities to be setup in the area thereby resulting in greater local employment, ultimately leading to overall development.

4. Technological Well Being:

- The Project activity has utilized gearless synchronous generator based Vestas WTGs for generation, which are designed for conditions specific to India. Thus, the project activity is propagating the latest technology, which is comparable with best practices in the renewable wind based energy sector anywhere in the world. Hence the project leads to technological well-being.

The project activity is generating electricity through a technology that is environmentally safe and sound.

2 SAFEGUARDS

2.1 No Net Harm

Project does not have any negative environmental and socio-economic impacts. Thus, this is not applicable for this project activity.

2.2 Local Stakeholder Consultation

Since this is the fifth periodic verification of the project activity, hence, local stakeholders' consultation details are not applicable in this project activity.

3 IMPLEMENTATION STATUS

3.1 Implementation Status of the Project Activity

Andhra Lake Ph-I envisages implementation of a 56 MW wind power project consisting of 70 Wind Electric Generators (WEGs) of individual capacity 0.8 MW by CLP Wind Farms (India) Private Limited. Total capacity of 56 MW has been commissioned. The first WEG under this project has commissioned on 19-Aug-2011 and last WEG has been commissioned on 28-Dec-2011. Thus, the project is now operation to its full operational capacity of 56 MW. A comprehensive list of WEGs commissioning dates are provided under section 1.7.

The project activity has been implemented as per the description in the registered VCS PD. The Project is owned by CLP Wind Farms (India) Private Limited and WWIL is responsible for operation and maintenance of the wind farm. The project has been under operation since

commissioning without any major breakdowns. Though normal breakdowns due to O&M measures are continuously being worked upon by the dedicated O&M contractor for the projects WEGs. There has been no events that may have an impact on the GHG emissions or removals during the current monitoring period.

Further, there are no changes to the project participant for the project activity during the monitoring period.

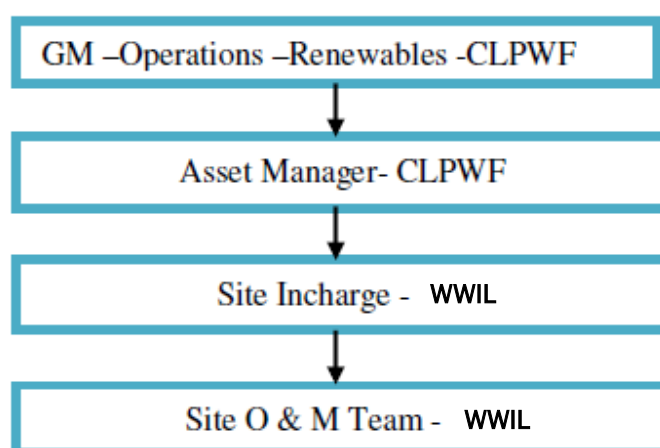
4.3 Monitoring Plan

The approved large scale methodology ACM0002 (version 12.3.0), stipulates the monitoring of the net electricity generation supplied by the project plant/unit to the grid.

The monitoring plan has been formulated according to the approved consolidated monitoring methodology in ACM0002 Version 12.3.0.

CLPWF has entered into a comprehensive Operation and Maintenance agreement with the manufactures of the WTGs for a period of 10 years, which is extendable at renegotiated terms. The contractor WWIL, under the O&M contract with CLPWF, is responsible for the operation and maintenance of the Project activity for the entire crediting period. The O&M personnel are qualified engineers and are trained at the WTG manufacturing facility of WWIL for operating and ensuring best performance of the WTGs.

The authority and responsibility of project management as well as registration, monitoring, measurement and reporting lies with the CLPWF. CLPWF has formulated a Project Team to ensure proper and continuous monitoring of the performance of turbines and generation of power. The operation and management structure implemented by the CLPWF for the purpose of the Project activity is illustrated below:



The Project activity essentially involves generation of electricity from wind, the employed WTG can only convert wind energy into electrical energy and cannot use any other input fuel for electricity generation.

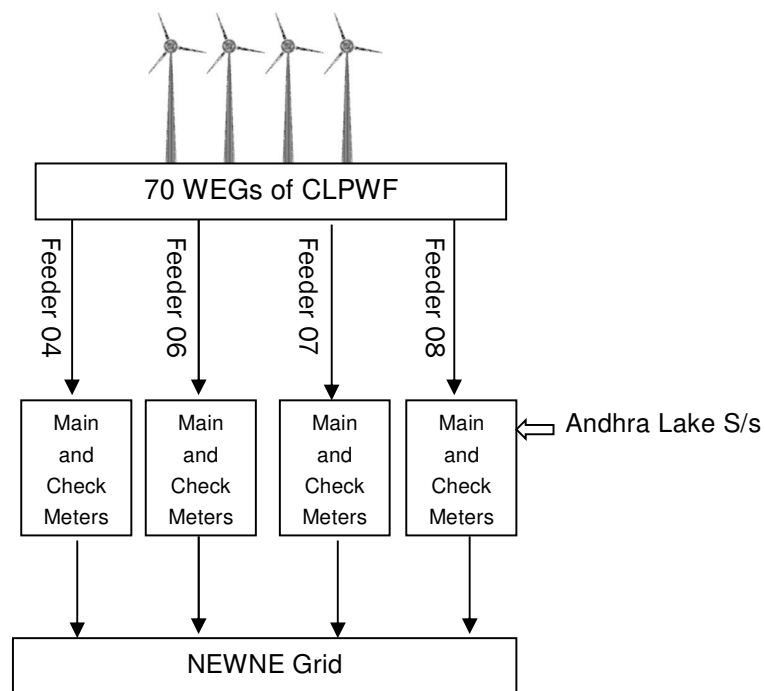
Frequency of meter reading: The meters installed at the metering point will have 15 minutes block online reading. However, the main/check meter reading at the metering point is undertaken jointly by the representative of the MSEDCL and authorized officials of the CLPWF on 1st day of every month for the preceding month.

Data archiving

Data has been archived electronically. The data would be archived two years after crediting period or last issuance whichever is later.

Calibration of Meters

The readings from main and check meters installed at the interconnection point has been checked every month at the time of metering of electricity generation. In case the meters are found to be operating beyond the permissible limits, it shall be immediately sent for calibration. The frequency of meter testing is once in 5 years. Location of the meters are mentioned below:



Apportioning of electricity:

In case dates of monitoring period do not match with the dates of Joint Meter Reading Sheets / Credit notes issued by Maharashtra State Electricity Distribution Co. Ltd. (MSEDCL)

Apportioning has been carried out based on ratio of generation data recorded using LCS meters installed at the WTG. The LCS meters do not require calibration as the energy readings of electricity generated at the LCS meter is cross verified by the energy calculated by inverting system installed in the WTGs.

The emission reductions of that particular period (from the date of registration of the project till the end of the month) will be calculated based on percentage generation of that particular period at WTG using LCS data multiplied with the total units generated in the month as per the Joint Meter Reading Sheets / Generation report issued by Maharashtra State Electricity Distribution Co. Ltd. (MSEDCL).

The sample calculation is furnished below:

Generation from CLPWF WTGs for the monitoring period = A (From LCS data) Generation from CLPWF WTGs for the billing period = B (From LCS data)

Net energy exported from CLPWF WTGs for the billing period = C (JMR/Generation share report by MSEDCL)

Net energy export used for calculation of emission reduction for the monitoring period = $(C * A/B)$

Calibration Details of billing meters for the project activity are provided in the Appendix 1.

5 QUANTIFICATION OF GHG EMISSION REDUCTIONS AND REMOVALS

5.1 Baseline Emissions

As per para 38 of ACM0002 version 12.3.0, Baseline emissions include only CO₂ emissions from electricity generation in fossil fuel fired power plants that are displaced due to the project activity. The methodology assumes that all project electricity generation above baseline levels would have been generated by existing grid-connected power plants and the addition of new grid-connected power plants. The baseline emissions are to be calculated as follows:

5.2 Project Emissions

5.3 Leakage

As per ACM0002 Version 12.3.0, no leakage has been considered for the calculation of emission factor.

The actual emission reductions for the current monitoring period are 18.82% higher than estimated emission reductions which are mainly due better availability of wind at site. Wind availability is a natural phenomenon which is beyond the control of CLP. Further, sensitivity analysis mentioned in registered project document shows that the equity IRR would cross the benchmark at 43.8% increase in PLF. Thus, same increase in generation for this periodic verification is in line with registered project document.
